Cameron County residents only can ask the Court to waive the filing fees through the Petition to Proceed In Forma Pauperis. You must fill out the forms and send them in with the divorce complaint. The Judge will decide if you can afford to pay based on your income. If the judge denies your petition, you will have to pay the filing fees before the Prothonotary can file anymore divorce papers.

The copies will be returned to you for you and your spouse's records. You will need these copies to fill in the dates on the Praecepto to Transmit the Record. If you have child custody, property or money disagreements with your spouse, you should talk to a lawyer.

We cannot file Marriage Settlement Agreements or QDRO's with the enclosed Divorce Documents, they must be presented in the correct format for our Judge and we ask you seek legal advice for this procedure. These divorce documents are for a divorce only.

1. If you are the person starting the divorce and filing for the divorce, you are the **Plaintiff** and your spouse is the **Defendant**. You or your spouse must have lived in PA for the past six (6) months. You must know the address of the Defendant so the Defendant can be mailed a copy of the divorce complaint and other papers. If you do not know the Defendant's address, you should speak with an attorney to learn your options.
2. Print clearly, use a BLUE ink pen, make sure your name and the Defendant's name are spelled correctly and also use middle names or middle initials. Make sure you sign and date all forms on the lines for the Plaintiff.
3. Pull out the following documents:
 - Notice to Defend and Claim Rights
 - Complaint for Divorce 3301C
 - Affidavit of Non-Military Service

Fill in all the blanks of these documents as best you can, make two (2) copies of these pages. Send all 3 documents to the Courthouse with a stamped, address envelope; we must have the original you filled out and both copies. We will return the copies with a dated stamp on them, this is your date of filing. This will also be the date you will start counting to have the divorce served on the other party. There is also a case number, please use this number on all divorce documents.

4. Once you receive your stamped copies back you must mail a copy to the defendant within the 30 days of the date stamp. You will have only 30 days for defendants that are in PA and 90 days if the defendant is out of state. Service can be done two ways, by certified mail or acceptance of service.

Certified mail: Go to the post office and ask for certified mail, you will need the defendant's address and need to fill out the green card that the post office gives you. The green card must be mark in #3 Service Type: Certified Mail Restricted Delivery and Signature Confirmation Restricted Delivery. **Only the Defendant can sign for these papers and it must be dated.** Put your address on this card also so it comes back to you. This is what we show the Judge to prove you served the Complaint for Divorce. Fill out the form Affidavit of Service and attach this green card to it, mail it to the office for filing.

Acceptance of Service: You can mail this with the Complaint for Divorce and if the defendant will fill it out and send it back to you this would work for service without doing it certified. One or the other will do.

Now you are on hold for 90 days.

5. Use the date that the defendant put on the green card from the post office or the date on the Acceptance of Service form as to when they received the Divorce Complaint, count 90 days, this is the date you can now sign the rest of the paperwork. You only have 30 days after signing to file them in our office.

Do not sign and date until after 90 days or they will be returned and delay the divorce.

6. Send the Defendant the Affidavit of Consent and Waiver of Notice of Intention to Request Entry of a Divorce Decree, have them signed, dated and returned to you.

Sign the Plaintiff's Affidavit of Consent and Waiver of Notice of Intention to Request Entry of a Divorce Decree.

Once you receive the paperwork from the defendant you can fill out the Praecipe to Transmit the Record.

This document is for two different kinds of divorces so only fill in the Section 3301C parts. Some of the file dates you will not know, leave blank and we will fill them in.

7. We also have an Affidavit of Intention to Retake Maiden Name Form if so needed, this is an additional \$10.00 fee for certification.

Send all the documents in for finalization with the Praeceptum to Transmit the Record and \$9 money order
